Subject: Tri-Daddy's BBQ & Southern Cooking Malt Liquor License

Department: Finance

Tri-Daddy's BBQ & Southern Cooking plans to open a restaurant at 1013 N. Osage. They have submitted an application to sell malt liquor by the drink for consumption on the premises.

Per Municipal Code Chapter 3, Tri-Daddy's BBQ & Southern Cooking has met all requirements for a liquor license at 1013 N. Osage. The pro-rated license fee is \$31.25. If approved, this license will expire July 31, 2013.

RESOLUTION NO. 1360

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI APPROVING A LIQUOR LICENSE FOR TRI-DADDY'S BBQ & SOUTHERN COOKING TO SELL MALT LIQUOR BY THE DRINK FOR CONSUMPTION ON THE PREMISES WHERE SOLD.

WHEREAS, Tri-Daddy's BBQ & Southern Cooking submitted an application for a liquor license to sell malt liquor in excess of 3.2 percent alcohol by weight and not in excess of 5 percent alcohol by weight or light wines containing not in excess of 14 percent alcohol by weight by the drink for consumption on premises where sold, and;

WHEREAS, Tri-Daddy's BBQ & Southern Cooking has met all requirements for a malt liquor license at 1013 N Osage and;

WHEREAS, the license will expire July 31, 2013 and;

WHEREAS, the Licensing Officer is hereby authorized to draft a letter to the Missouri Department of Liquor Control advising that a liquor license has been conditionally approved contingent upon receipt of a State liquor license and;

WHEREAS, upon receipt of the State liquor license, a City liquor license will be issued.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Nevada, Missouri that the application for a liquor license for Tri-Daddy's BBQ & Southern Cooking, is hereby approved this 19th day of March, 2013.


RETURN SERVICE REQUESTED

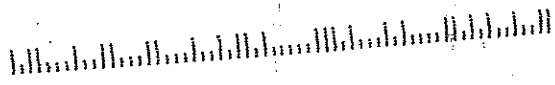
