- 1. While the annual Bushwhacker Days festival may benefit some businesses, it is a burden to our businesses in that it interferes with parking, the noise interferes with the conduct of business, and customers cannot conveniently reach our businesses; and
- 2. The location of the trailer used as a stage for performances is a particular burden to the businesses located on the south side of the square; and
- 3. It is respectfully suggested that the business community and the various community organizations would be better served if the Bushwhacker events were moved to a more convenient location off of the square, or in the alternative that the performance stage be moved to the inside curb next to the courthouse lawn.
