

# PETITION

TO: THE CITY COUNCIL OF NEVADA MISSOURI  
 THE BUSHWHACKER COMMITTEE  
 THE NEVADA VERNON COUNTY CHAMBER OF COMMERCE

THE UNDERSIGNED, owners, managers, operators, and customers of businesses in downtown Nevada respectfully suggest that:

1. While the annual Bushwhacker Days festival may benefit some businesses, it is a burden to our businesses in that it interferes with parking, the noise interferes with the conduct of business, and customers cannot conveniently reach our businesses; and
2. The location of the trailer used as a stage for performances is a particular burden to the businesses located on the south side of the square; and
3. It is respectfully suggested that the business community and the various community organizations would be better served if the Bushwhacker events were moved to a more convenient location off of the square, or in the alternative that the performance stage be moved to the inside curb next to the courthouse lawn.
