**A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AUTHORIZING THE EXECUTION OF A GOVERNMENTAL COOPERATIVE CONTRACT WITH VERNON COUNTY AND THE VERNON COUNTY ASSESSOR PERTAINING TO ASSESSMENTS OF REAL AND PERSONAL PROPERTIES WITHIN THE CORPORATE LIMITS OF NEVADA, MISSOURI IN CONFORMITY WITH SECTION 70.220 ET. SEQ. RSMo., 2000.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**

**Section 1.** The Governmental Cooperative Contract attached hereto as Exhibit "A" and incorporated herein by reference is approved as a contractual obligation of the City of Nevada, Missouri.

**Section 2.** The Mayor and City Clerk are hereby authorized and directed to execute said Governmental Cooperative Contract on behalf of the City of Nevada, Missouri, and to affix the municipal seal thereto and to attest the same.

## EXHIBIT "A"

### GOVERNMENT COOPERATIVE CONTRACT

**THIS AGREEMENT** entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013, **BY AND BETWEEN** the City of Nevada, Missouri, hereafter referred to as the City and the County Commission, Vernon County, Missouri, hereafter referred to as the County Commission and the Office of the County Assessor of Vernon County, Missouri, hereafter referred to as the County Assessor.

#### WITNESSETH:

**THAT WHEREAS**, the parties desire to work out an efficient and sound system for the assessment of real and personal properties within the corporate limits of Nevada, Missouri and to execute an intergovernmental cooperative contract in conformity with Section 70.220 et. seq. RSMo., 2000

**NOW, THEREFORE**, it is mutually agreed that:

1. The County Assessor will carry out the assessment of real and personal properties within the corporate limits of Nevada, Missouri, in accordance with RSMo. ,2000.
2. The assessments, which identify real and personal properties within the corporate limits of the City of Nevada, will be provided to the City of Nevada, Missouri, or its agent, for the preparation of tax books and tax statements.
3. The County Assessor will prepare and mail a personal property assessment sheet to each resident of the City of Nevada.
4. The City will make reimbursement directly to the Vernon County Assessor a sum of \$200.00 per month for all procedures necessary to effect the provisions of this agreement, as provided for in Section 50.332 RSMo., 2000. This payment shall cover the following: (1) determining what properties are within the corporate city limits of Nevada; (2) making adjustments of City of Nevada assessments; (3) preparing legal descriptions and assigning tax numbers to be used by the City.
5. The agreement shall begin on September 1, 2013 and continue until the term of the current Assessor expires on August 31, 2017.
6. Any request for amendments to or modifications of this agreement by either party shall be submitted in writing by July 1<sup>st</sup> of the current tax year
7. This agreement shall be subject to the approval of the City Council of the City of Nevada, Missouri, the County Commission of Vernon County, Missouri and the County Assessor of Vernon County, Missouri.
