This resolution will authorize the Mayor of the City of Nevada to execute a Certification Regarding Government-Wide Restriction on Lobbying as part of the Missouri DNR SRF loan program process. The certification states that funds received under this program will not be spent for the purpose of lobbying federal officials or agencies.

RESOLUTION NO. 1379

A RESOLUTION OF THE CITY OF NEVADA, MISSOURI AUTHORIZING THE FILING OF A CERTIFICATION REGARDING GOVERNMENT-WIDE RESTRICTION ON LOBBYING.

WHEREAS, the City of Nevada intends to enter into an agreement with the Missouri Department of Natural Resources for a State Revolving Fund loan, to be used for improvements to the City's sewer system, and;

WHEREAS, as part of this process, the Missouri DNR requires the filing of a Certification Regarding Government-Wide Restriction on Lobbying, bearing the signature of the Mayor as Certifying Official;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Nevada, Missouri that Seth Barrett, the Mayor of the City of Nevada, is hereby authorized to sign the attached Certification Regarding Government-Wide Restriction on Lobbying, and to submit it to the Missouri Department of Natural Resources.

**CERTIFICATION REGARDING GOVERNMENT-WIDE
RESTRICTION ON LOBBYING**

(For contracts, grants, cooperative agreements, and loans over \$100,000)

The undersigned certifies, to the best of his or her knowledge and belief that:

- (1) No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, or an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of and Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
- (2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant loan, or cooperation agreement, the undersigned shall complete and submit Standard Form LLL, "Disclosure Form to Report Lobbying," in accordance with it instructions.
- (3) The undersigned shall require that the language of this certification be included in the award documents for all subawards (at all tiers, including contracts under grants, loans, and cooperative agreements, subcontracts, and subgrants) over \$100,000, and that all subrecipients shall certify and disclose accordingly.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into submission of this certification is a prerequisite for making or entering into this transaction imposed by Section 1352, Title 31, U.S.C. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
