Absent: None

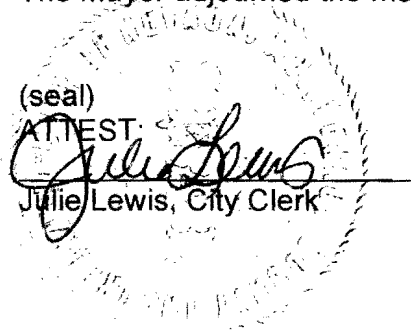
### ADJOURNMENT
