A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI, AMENDING ORDINANCE NO. 8468 AUTHORIZING THE EXECUTION OF A GOVERNMENTAL COOPERATIVE CONTRACT WITH THE VERNON COUNTY COMMISSION PERTAINING TO THE BILLING OF REAL ESTATE AND PERSONAL PROPERTY TAXES WITHIN THE CORPORATE LIMITS OF NEVADA, MISSOURI.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

**Section 1.** The agreement attached hereto as Exhibit A and incorporated herein by reference was approved as a contractual obligation with the City of Nevada, Missouri.


**Section 2.** Whereas Item #6 of the contract has been amended to reflect the new amount of \$ 3,930.40.

## GOVERNMENTAL COOPERATIVE CONTRACT

**THIS AGREEMENT**, entered into this 21<sup>st</sup> day of March, 2022, **BY AND BETWEEN** the City of Nevada, Missouri, hereafter referred to as City and the County Commission, Vernon County, Missouri, hereafter referred to as County.

### WITNESSETH:


**THAT WHEREAS**, the City wishes to contract with the County for computer services associated with the 2021 real estate and personal property tax billings and the City and County wish to execute an inter-governmental cooperative contract in conformity with Section 70.210 et. seq. RSMo, 2000.

**NOW, THEREFORE**, it is mutually agreed that the City will receive the following services:

1. The County will include the City of Nevada taxes on the Center Township and Washington Township tax statements.
2. The County will provide original 2021 tax book when statements are printed (One copy alphabetical order; two copies - sub-division order)
3. The County will provide delinquent tax book as of December 31, 2021 (One copy alphabetical order; one copy - sub-division order)
4. The County will provide delinquent tax book as of February 28, 2022 (One copy alphabetical order; one copy - sub-division order)
5. The County will provide monthly listing of payments from statement and allocation of payments by fund.
6. Vernon County will receive from the City **\$3,930.40** to be paid by December 31, 2021, for use of computer equipment, data entry, printing and other services required.
7. No liability for errors is assumed by Vernon County, though every attempt will be made to provide correct materials to the City.
8. It is understood that one and one-quarter percent (1.25%) will be deducted from all taxes collected by the County and deposited into the Vernon County Assessment Fund as required by Section 137.720 RSMo, 2000.

9. Any computer programming required for the above items will be the responsibility of, and completed at the expense of the City.
10. This agreement shall be for only one year, and shall be subject to the approval of the City Council of the City of Nevada, Missouri and the County Commission of Vernon County, Missouri.


