ORDINANCE NO. 8475

**A SPECIAL ORDINANCE AMENDING THE FIVE-YEAR CAPITAL IMPROVEMENT PLAN (CIP) APPROVED BY ORDINANCE 8460.**

**WHEREAS**, the Planning Commission held a Public Hearing seeking comments on the proposed Five-year Capital Improvement Plan (CIP) on Tuesday, September 14, 2021; and,

**WHEREAS**, The City Council approved the 2022 Budget and Five-year Capital Improvement Plan (CIP) at the December 14, 2021 Council Meeting; and,

**WHEREAS**, the Planning Commission in accordance with Section 6.6 (b) of the Charter of the City of Nevada recommends amending the capital program as submitted by the City Manager; and,

**WHEREAS**, the Planning Commission voted at the February 8, 2022 meeting to start planning and working on recommendations for the 2023 CIP beginning at their March 2022 Meeting.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**

**Section 1.** The Council finds the adoption of the proposed plan amendment as recommended by the Planning Commission is in the best interest of the City of Nevada.


**Section 2.** The Council of the City of Nevada hereby adopts the Amendment as depicted by Exhibit "A" attached hereto and incorporated herein by reference.


**Section 3.** This ordinance shall be in full force and effect after its passage.
