MEMORANDUM OF AGREEMENT

This Memorandum of Agreement has been entered into this _____ day of 2012 by and between the City of Nevada, a municipal corporation of the state of Missouri (hereinafter referred to as "City"), and Alliance Water Resources, Inc., (hereinafter referred to as "Alliance").

This Memorandum of Agreement has as its purpose to modify the initial Professional Service Agreement Dated December 28, 2010 between City and Alliance.

Pursuant to Section 5.1, the Service Agreement is modified under the following sections:

5.1 Alliance base compensation per this Agreement shall be \$126,276.92 per month for the fiscal year beginning January 1, 2013 and ending December 31, 2013. The annual Repair Limit for this term shall be \$79,000 and the Chemical limit for this term shall be \$82,200.00.

Proposed Budget**

Dear Mr. Kerhman,

Alliance Water Resources (AWR) is pleased to present the proposed budget for 2013 for your review and consideration. We are requesting an annual increase of 0.9% to the existing contract amount, making the new annual total \$1,515,323.00 (\$126,276.92 monthly).

We have had another exciting year continuing training a top notched staff along with addressing several challenging tasks such as fine tuning H2S scrubbing units at the Water Treatment Plant along with constantly producing a “stable” water for the residents, improving the safety program, on going staff training, implementing new water meter reading routes to accommodate monthly billing and preparing SOPs (Standard Operation Procedures) for both Water and Wastewater Treatment Plants. I hope our monthly reports and communication with you and the Council have been helpful.

The largest increases are in employee health insurance (8%) and Chemical Expense (9%) directly relating to operations of the scrubbers and producing a constant “stable” water from the Water Plant along with vendor price increases. The Repair Expense cap is remaining the same at \$79,000 but the Chemical Expense cap will increase from \$75,500 to \$82,200.
