Subject: Nevada Parks Shelter Fee Structure

Department: Parks and Recreation

The Park Board met in regular session on Wednesday, November 28, 2012 and discussed the fees within the Parks and Recreation Department. It is the recommendation of the Park Board to make the following changes in fees for the Nevada Parks Shelters:

All park shelters in Walton, Spring Street, Radio Springs, and the North Shelter, South Shelter, and Amphitheater at Marmaduke Park from \$10.00 per hour to \$10.50 per hour.

Colonel John Marmaduke Community Building (Friday and Saturday)

2-hour block	from \$37.50 to 39.50
4-hour block	from \$75.00 to \$79.00
Each Additional Hour	from \$10.00 to \$10.50

Colonel John Marmaduke Community Building (Monday through Thurs) and Non-Profit Fee

2-hour block	from \$25.00 to \$26.00
4-hour block	from \$50.00 to \$53.00
Each Additional Hour	from \$10.00 to \$10.50

ORDINANCE NO.

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE STRUCTURE FOR THE USE OF THE NEVADA PARKS SHELTERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Nevada Parks Shelters shall become effective January 1, 2013

Upper Shelter (per hour)	\$10.50
Accessible Shelter (per hour)	\$10.50
Island Shelter (per hour)	\$10.50
<u>Spring Street Park</u>	
West Shelter (per hour)	\$10.50
East Shelter (per hour)	\$10.50
<u>Walton Park</u>	
Lake Shelter (per hour)	\$10.50
<u>Marmaduke Park</u>	
North Shelter (per hour)	\$10.50
South Shelter (per hour)	\$10.50
Ampitheater (per hour)	\$10.50

All reservations are to be made 1 day prior on all shelters	
<u>Colonel John Marmaduke Community Building</u> (Friday & Saturday)	
2-hour Block	\$39.50
4-hour Block	\$78.75
Each Additional Hour	\$10.50
<u>Weekday Fees (Mon – Thurs) & Non-Profit</u>	
2-hour Block	\$25.50
4-hour Block	\$51.00
Each Additional Hour	\$10.50
Deposit	\$100.00

Section 2. This ordinance amends and supersedes user fees heretofore proposed by City ordinance.

Section 3. This ordinance shall be in full force and effect from and after its passage and adoption.
