ORDINANCE NO.

A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE STRUCTURE FOR THE USE OF THE WALTON AQUATIC CENTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:

Section 1. The following fees for use of the Walton Aquatic Center shall become effective January 1, 2013

Age 3 & Up	\$3.75
2 & Under with and adult 16 and older	FREE
<u>Season Passes</u>	
Individual	\$75.00
Each Additional	32.00
Family Pass (4 or more immediate family members)	168.00
<u>Half Season Passes</u>	
Individual	\$37.00
Each Additional	\$16.00
Family	\$84.00
<u>Pool Rental</u>	
Per hour	\$105.00
Per lifeguard per hour	\$12.00

<u>Coupons</u>	
15 Coupons	\$50.00
30 Coupons	\$90.00
150 Coupons	\$275.00

Section 2. This ordinance amends and supersedes user fees heretofore proposed by City ordinance.

Section 3. This ordinance shall be in full force and effect from and after its passage and adoption.
