Subject: Franklin P. Norman Community Center Fee Structure

The Park Board met in regular session on Wednesday, November 28, 2012 and discussed the fees within the Parks and Recreation Department. It is the recommendation of the Park Board to make the following changes in fees for the Franklin P. Norman Community Center:

Small gym per hour	from \$15 to \$15.75
Half of large gym per hour	from \$15 to \$15.75
Non-profit gym rental	from \$15 to \$15.75
Meeting room per hour	from \$10 to \$10.50
Kitchen usage fee	from \$15 to \$15.75
Game room per hour	from \$15 to \$15.75

**ORDINANCE NO.**

**A SPECIAL ORDINANCE OF THE CITY OF NEVADA, MISSOURI ESTABLISHING A FEE STRUCTURE FOR THE USE OF THE FRANKLIN P NORMAN COMMUNITY CENTER.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEVADA, MISSOURI, THAT:**

**Section 1.** The following fees for use of the Franklin P Norman Community Center shall become effective January 1, 2013.
